PROGRAM OVERVIEW

The Kinder Institute's Society of Fellows is a competitive, all-expense-paid fellowship program exclusive to University of Missouri undergraduates that provides students with the unique opportunity to spend a year engaged in a collective, interdisciplinary exploration of the philosophical foundations, historical development, and contemporary practice of constitutional democracy in the United States and abroad.

Members of the 2017-2018 Society of Fellows will participate in the following events: Residential Summer Seminar: Tuesday, August 8 – Friday, August 11, 2017

To kick off the Society of Fellows program, qualifying applicants will spend four days and three nights at the historic Tiger Hotel in downtown Columbia examining key ideas, figures, and events in the history of American constitutional democracy through a series of lectures and discussions led by Kinder Institute faculty. Full attendance at and participation in the 2017 Summer Seminar is a required component of the Society of Fellows.

Dinner Discussions: September 2017, November 2017, February 2018, April 2018

Fellows will continue their inquiry into democratic thought and history during the school year through quarterly lunch and dinner discussions with MU faculty members and invited guests of the Kinder Institute. These discussions will be held in Columbia on one afternoon or evening during each of the four months listed above. Attendance at all discussion events is also a requirement of participation in the Society of Fellows.

Student-edited Journal on Constitutional Democracy (optional)

Fellows will also have the exclusive opportunity to join the 2017-2018 staff of the student-run *Journal on Constitutional Democracy*. Each volume of the *Journal* is organized around a new theme chosen by the staff and consists of student articles that examine the complex history of constitutional democracy in the United States and around the globe as well as the application of foundational constitutional principles in today's political environment. Students interested in receiving course credit for their participation in creating the *Journal* will have the opportunity to sign up for the first half of the yearlong, 3-credit hour *Journal on Constitutional Democracy* class (HIST/POL SC 4975) during spring enrollment for Fall 2017.

The Society of Fellows application consists of three components: (1) A questionnaire, formatted as an interactive PDF and found on page 2 of this document; (2) A current resume; and (3) Two short essay responses, prompts for which are found on page 3 of this document.
