

In the early nineteenth century, the Shawnee Cattle Trail ran from Texas to Missouri, passing through Oklahoma, Kansas, and Colorado. The 4th Annual Shawnee Trail Regional Seminar aims to foster intellectual connections between institutions in this region. The seminar series will allow scholars working on any topic related to American politics or constitutionalism to exchange ideas with colleagues in a serious but convivial setting. Scholars interested in American constitutional and political development and / or American political thought are particularly encouraged to participate. Meetings take place annually, rotating between Columbia, MO and other locations (the 2018 meeting is scheduled for Colorado Springs). A roundtable format is utilized, with presenters pre-circulating papers in advance of the meeting.

A limited number of conference papers will be selected for inclusion in an edited volume surrounding the theme "The American Contribution to Citizenship and Constitutionalism." To apply for a spot in the seminar, please send a 200-word abstract of your proposed paper to spittz@uccs.edu, using 'Shawnee IV' in the subject line, by Jan. 12, 2018. A full seminar schedule will be announced in March, and working papers will be distributed in early April.
