



## CALL FOR APPLICATIONS

### 2019 KINDER SCHOLARS SUMMER PROGRAM IN WASHINGTON, D.C.

A competitive academic summer program available exclusively to University of Missouri undergraduates, the Kinder Scholars Program in Washington, D.C., offers students a unique opportunity to spend up to ten weeks in the nation's capital exploring the intellectual origins, historical narrative, and contemporary practice of American constitutional democracy through a combination of coursework and experiential learning.

The Kinder Institute on Constitutional Democracy provides all participants with housing for the duration of the Kinder Scholars Program as well as a \$1,000 stipend to help offset other expenses related to spending a summer living, studying, and interning in D.C. While students are responsible for paying the per-credit hour cost of enrolling in courses associated with the program, some tuition assistance may also be available.

Students who are returning to the University of Missouri in Fall 2019 for their junior or senior year are eligible to apply. The application deadline for the 2019 Kinder Scholars D.C. Summer Program is **Friday, October 26, 2018**.

### Program Description

In order to provide a truly immersive learning experience, the curriculum for the Kinder Scholars D.C. Summer Program is structured around two core components:

**Scholarship:** First and foremost, this is an academic program, and all participants must enroll in and complete assigned coursework for HIST/POL SC 4900: Beltway History & Politics. A three-credit hour course team-taught by Kinder Institute faculty in a seminar setting, the Beltway History & Politics class engages students in an in-depth, interdisciplinary examination of the philosophical foundations and historical development of democracy in America, from the colonial age into the twentieth century. The course will follow MU's academic calendar for the eight-week summer session, meeting weekly from June 3, 2019 – July 26, 2019.

In addition to regular class sessions, the syllabus for the course includes weekly field trips designed to enhance students' understanding of the nation's constitutional history by visiting sites in and around D.C. where it actually unfolded. In the past, these field trips have taken Kinder Scholars participants to the Sewall-Belmont House, Jefferson's Monticello, Gettysburg, and Frederick Douglass' home at Cedar Hill. All field trips will take place on Friday, and itineraries will be distributed to students far in advance of the trip dates.

**Internship:** So students can supplement their work in the classroom with practical experience, the Kinder Scholars Program also requires that participants intern Monday-Thursday (minimum 25 hours/week) at an organization in D.C. whose mission broadly relates both to their personal interests and their scholarly examination of the nation's political history, traditions, and institutions. While faculty members affiliated with the Kinder Scholars Program are more than happy to offer assistance and advice when it comes to finding summer work in D.C., participants are ultimately responsible for arranging their own internships. Students can receive up to six credit hours for the work they do at their internships by enrolling in HIST or POL SC 4940, the academic internship programs offered by the MU Departments of History and Political Science.

D.C. is rich with internship opportunities, and students can pursue any number of paths during their time in the Kinder Scholars Program by working on Capitol Hill, with a K Street lobbying firm, in the not-for-profit sector, or at one of the city's many museums, archives, or media outlets. Past participants have interned at sites including: National Public Radio, the National Parks Service, the offices of Senators Claire McCaskill and Joni Ernst, the Federalist Society, Victory Fund, NBC D.C., the Smithsonian, the Federal Reserve, SCOTUSblog, AEI, the Center for International Policy, and the Child Welfare League of America.

## Housing

Program participants will live together in apartments in the Washington Intern Student Housing (WISH) facility at 2807 Connecticut Avenue NW, in the heart of D.C.'s historic Woodley Park neighborhood. The WISH-Woodley Park facility is a secure apartment building that provides residents with a 24-hour onsite staff, an assortment of modern amenities, and a community of students and interns from around the globe. Whether commuting to work or exploring the city, with the Woodley Park/Adams Morgan Metro stop just blocks from the apartments, students can be in Capitol Hill, Dupont Circle, or downtown D.C. within minutes of leaving home. Kinder Scholars coordinators will solicit feedback about housing assignments from participants, but decisions about these assignments are ultimately up to the coordinators and housing providers. While the Beltway History & Politics seminar runs from June 3, 2019 – July 26, 2019, students will be able to live in the WISH-Woodley Park facility one week prior to the beginning of the course and one week after its conclusion.

## TO APPLY FOR THE 2019 KINDER SCHOLARS D.C. SUMMER PROGRAM

The first phase of the application process for the Kinder Scholars D.C. Program involves submitting four components: a questionnaire found on page 3 of these materials formatted as an interactive PDF, responses to the series of short answer questions found on page 4, a resume, and two letters of reference (to be submitted by students' referees). To be considered for admission, all components must be typed and e-mailed as separate attachments to Kinder Institute Communications Associate Thomas Kane at [KaneTC@missouri.edu](mailto:KaneTC@missouri.edu) no later than **Friday, October 26, 2018**. Only students returning to University of Missouri in Fall 2019 for their junior or senior year are eligible to apply.

After the initial review of applications is completed, the selection committee will then conduct interviews with finalists for admission into the 2019 Kinder Scholars Program. These interviews will take place during the week of November 19, 2018, and applicants will be notified of their selection status after Thanksgiving Break.

**Note:** Each year, applications far exceed the number of spaces available in the Kinder Scholars D.C. Summer Program. We will be running a waiting list, and we reserve the right to replace anyone who was initially selected with someone from the waiting list if he or she has not secured an internship by May 1, 2019.

When submitting application materials, please use your name and "2019 Kinder Scholars Application" in the subject line of your e-mail, and save the three application components that you will supply as:

- Your Last Name\_KS Application\_ Short Answer
- Your Last Name\_KS Application\_ Resume

Please only submit materials in **Microsoft Word or PDF format**, and have your letters of reference sent separately to [KaneTC@missouri.edu](mailto:KaneTC@missouri.edu). 3. What is your ideal internship and why?
4. What MU experience or class do you feel has best prepared you to be a positive, unique contributor to the Kinder Scholars Program?
5. The “Beltway History & Politics” course focuses on American political thought and history from the Founding era into the early twentieth century. If you could design one week of the course, what would you have the class read, where would you go on a field trip, and why?

## COMPLETING THE KINDER SCHOLARS APPLICATION

There are two more required components of the 2019 Kinder Scholars application

- A current copy of your resume, saved as “Your Last Name\_KS Application\_Resume”
- Two letters of reference that address topics such as: your academic credentials; your ability to adapt to new situations; your ability to work and get along with peers; and your ability to be a strong, positive representative of MU and the Kinder Institute. At least one of these letters **MUST** be from an MU faculty member and preferably both would be. Please have your referees submit their letters directly to Thomas Kane, **KaneTC@missouri.edu**, with your name and “Kinder Scholars Reference Letter” in the subject line.

Once you have completed the questionnaire, short answer questions, and resume, please send them as separate attachments in the same email to Kinder Institute Communications Associate Thomas Kane at **KaneTC@missouri.edu**
